2025 Multilateral Financial-Cyber Forum

As part of the official activities of Expo 2025 Osaka, Kansai, Japan, a special Multilateral Financial-Cyber Forum will be held in Osaka, hosted by the Israeli Ministry of Finance, the Israel National Cyber Directorate (INCD), and the Israeli Ministry of Foreign Affairs. This high-level forum will feature two key tracks—the Financial-Cyber Forum and the Cyber Seaport Forum—designed to foster international collaboration and address the growing complexity of cybersecurity across the financial sector and the broader digital ecosystem. Senior stakeholders, policymakers, and cybersecurity experts from around the world will convene to share insights, examine common challenges, and explore collaborative strategies to enhance global cyber resilience.

The Multilateral Financial-Cyber Forum will pursue several key goals: to strengthen global cooperation in addressing systemic cyber and financial threats; Build channels for collaboration on “Low Probability, High Impact” and “Black Swan” events; Promote a common language and framework for cross-border coordination; and explore real-world scenarios to assess potential global impacts.

Sessions will feature practical case studies and lessons learned from recent incidents, with a focus on managing threats in dynamic, high-risk environments. The international dialogue will continue in Tokyo as part of Cybertech Tokyo 2025, further advancing cross-border engagement and cybersecurity innovation.

Originally launched at Expo 2020 Dubai, the forum has evolved into a trusted multilateral platform for dialogue and collaboration. As digitalization accelerates, the financial sector faces a new generation of Systemic Non-Financial Risks (NFRs)—from cyber threats and natural disasters to energy crises and terrorism—demanding swift, coordinated responses on a global scale.
